Transportation Commission Sets Hearing on New Administrative Rules

PIERRE, S.D. – The South Dakota Transportation Commission set a hearing date of Aug. 27, 2015, to review and adopt rules for the County Highway and Bridge Improvement Plans and the Bridge Improvement Grant (BIG) fund.

During the 2015 Legislative Session, legislation was passed which included the establishment of a new grant program to assist with repair and maintenance of bridges on the local highway systems. Once fully implemented, the fund will provide \$15 million annually to address local bridge needs.

The bill gives the Transportation Commission authority to promulgate rules on the application process, timelines, guidelines and criteria it will use to award and distribute money from the newly created BIG fund.

LesA –

Thank you again for your interest in the Transportation Alternatives Program (TAP) funding. As we discussed on the phone at the time the Letters of Intent (LOI) were due, we have evaluated your proposed project for eligibility.

Although there are some road reconstruction projects that are eligible for TAP, they are primarily roads that are being reduced from an interstate or divided roadway section to a smaller facility that includes more boulevard/green space for storm water management or bike/pedestrian/transit type accommodations in a more 'complete street' type of design. Unfortunately, the reconstruction of West Shore Drive does not meet either of these criteria and would likely not be highly ranked by the TAP Advisory Committee.

Although this project does not qualify for TAP, you may wish to contact Doug Kinniburgh (773.4284) or Paula Huizenga (773.6253) in our Local Government Assistance office. They oversee the Community Access, Agri-Business and Industrial Park Road grants, as well as other funding sources that may be more applicable to this project.

If you have an alternate project you would like to submit for TAP funding, in place of the West Shore Drive project, please let me know by noon on Friday, July 31st. Please don't hesitate to call with any questions.
